The association has the right to direct emergency actions or maintenance within any private condo unit. Entry may be without notice in the case of an emergency, and may be with reasonable notice if it is not an emergency. If a resident does not provide the association (through the management company) with a unit key, should entry to take emergency measures or make emergency repairs become necessary, the association may direct the management company to have a locksmith change the locks to allow access; and the owner or resident will be charged for the expense. Owners and residents are able to provide an Emergency Voluntary Designated Contact (VDC) in Emergency Authorization. By providing this VDC, the owner or resident agrees to the following: I (unit occupant) have read Florida Law and understand it. If the Association is unable to reach me and an emergency arises in my unit, I have listed the following parties and their contact numbers who have my unit key and authorization to access my unit # _____ located in Building ______ Racquet Club NE Condominium. I understand that, should my VDC fail to respond to attempts to contact, the association will proceed with accessing my unit to address any emergency.
